# SPECIAL GUEST - TOM GERVAIS Re- OAPSB Zone 6

Tom Gervais, Police Services Advisor, Operations Unit, External Relations Branch, Ministry of Community Safety and Correctional Services addressed the Board. Mr. Gervais explained that his role is to

- provide information and advice to Police Boards, Chiefs, etc.
- Monitor police officers and Boards to ensure the Police Services Act is being met
- Inspect police forces

Mr. Gervais is a member of several organizations, including the Future of Policing Advisory Committee, which is currently evaluating policing in Ontario and what should/should not be a core practice. He also advised that the Cost of Policing effort is

ongoing.

Mr. Gervais spent 30 years with the Windsor Police Service. He has worked for the Ministry for 10 years and was responsible for the Northern Ontario territory until March 2010. Mr. Gervais stated that the Lambton Group's nine member municipalities make it the largest Board in Ontario.

Mr. Gervais inquired about the Board composition and framework. He also inquired about public access to minutes of Board meetings.

Moved by A. Syer, seconded by S. Miller THAT the municipalities within the Lambton Group policing contract have the minutes of the Police Board meetings accessible to the public, preferably, through posting on their municipal website.
